On the Autobahn A73 (Nuremberg – Bamberg), take the exit Erlangen-Nord and follow the signs “Uni-Kliniken”. From Spardorfer Strasse, turn right onto Palmstrasse (runs into “Palmsanlage”). After crossing the Schwabach stream, the auditorium center is immediately on your right hand side. The entry to the “Uni-Kliniken” parking structure is here.

PARKING SITUATION

Parking is available in the parking structure “Parkhaus Uni-Kliniken”. From there, it is brief walk to the lecture center of the Universitätsklinikum. As this parking lot is occupied quickly, we recommend you to use the “Großparkplätze” behind the central train station. From there, it is a short taxi drive or approximately 15 minutes’ walk to the venue.

ARRIVING BY TRAIN

Erlangen Station is around one kilometer from the lecture center. Erlangen is a stop for ICE (Intercity-Express), IC (InterCity), RE (Regional-Express) and S-Bahn service. Taxis may be found at the square in front of the central train station “Bahnhofsplatz”.

ARRIVING BY PLANE

From Nuremberg Airport, the U2 underground takes you directly to Nuremberg Main Station. From there, the train trip to Erlangen Station takes about 20 minutes. Nuremberg Airport is around 20 kilo-meters from the center of Erlangen. Taxis are available at the airport.

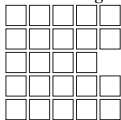
